1 AIRGRAM

Works across Microsoft Teams, Google Meet, and Zoom meetings via a simple browser extension to record, transcribe, and share meeting notes.

2 FIREFLIES.AI

The ability to do everything from generating a quote to writing a blog post to crafting a report from your meeting notes.

3 FELLOW

Makes it easy to manage the entire meeting experience, from building a meeting agenda to generating minutes to gathering feedback.

4 KRISP

Uses AI to improve voice clarity, giving you clearer, crisper meetings, along with free, unlimited meeting transcriptions.

5 AVOMA

Avoma does it all, from agenda templates to collaborative note-taking to AI-generated notes and topics, saving you time and effort.

6 TL;DV

Works with Zoom and Google Meet to record and transcribe your meetings. There is a free version or a pro version with more features.

7 EQUAL TIME

Driving inclusion by showing who participates most in meetings so stakeholders know which voices are underrepresented.

8 REWATCH

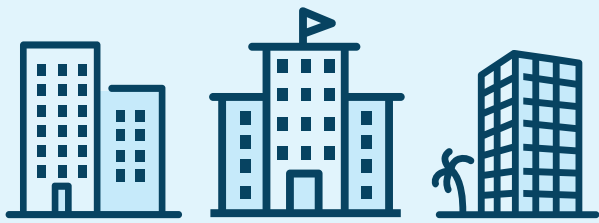
A collaborative video workspace which centralizes all meeting videos, notes, and discussions in one place as well as enabling easy video content creation.

NEW EUROPEAN TRAVEL REQUIREMENT FOR 2024

Heading to Europe for any 2024 healthcare meetings? Then you (and your attendees) need to know about this important new travel requirement.

Beginning in 2024 or 2025, depending on your country, people will need a special travel authorization (ETIAS) to enter the Schengen area of Europe, including popular event destinations such as France, Germany, Italy, and Spain. The United Kingdom is not part of the Schengen area, so doesn't require ETIAS authorization.

The application costs €7, and is good for three years, meaning you can easily return to the Schengen area during this time.

If you are planning on exhibiting or presenting at any European healthcare expos or conferences in the near future, check the ETIAS website for the latest travel requirements⁶.

ATTENDEE VOICE RECOGNITION

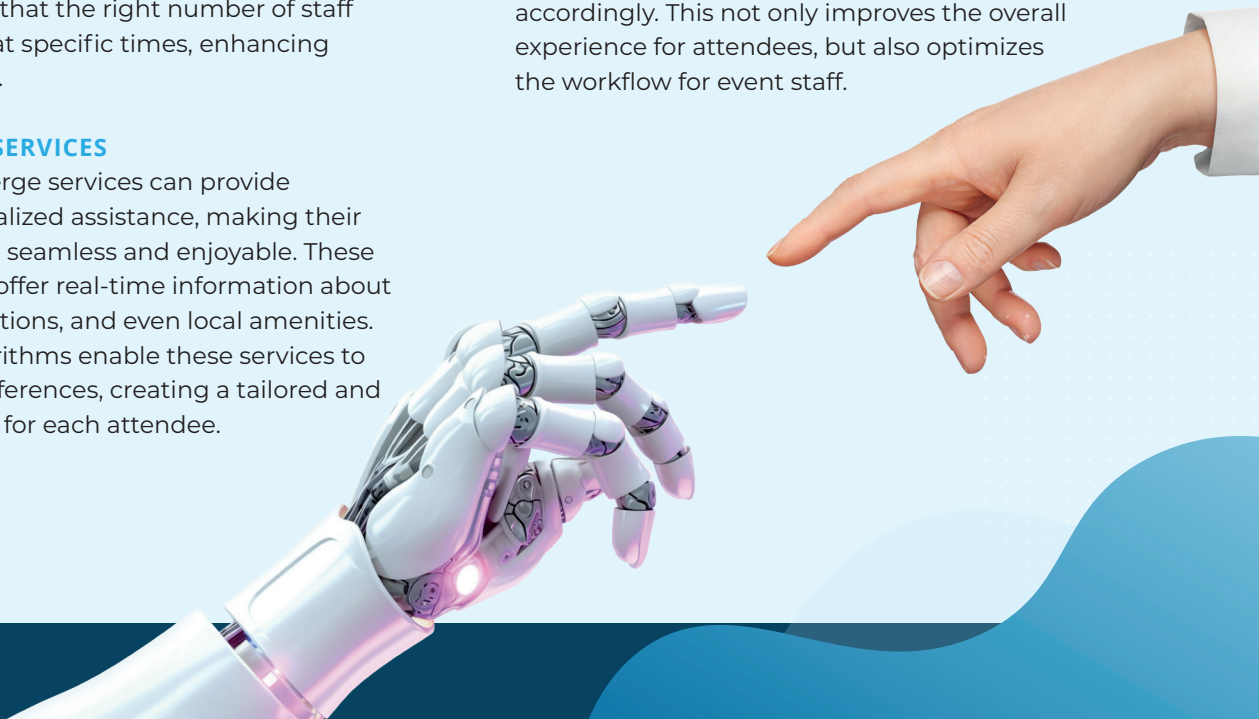

EXPLORE DIFFERENT VENUE OPTIONS

43% of event organizers seek venue recommendations via event communities, such as Slack, WhatsApp, or Facebook².

While hotels and dedicated event centers are the most common options for healthcare events, it could be worth thinking outside the box to consider other spaces. How about a library, a science museum, or a gallery? They may be cheaper than your usual event venues, which can help you stay within budget while providing a memorable experience for your attendees.

CONSIDER A CHANGE OF SCENE

Unsurprisingly, certain cities command much higher rates for event venues. That's why it can pay to be open-minded about where you host your healthcare events. For instance, instead of targeting Miami, consider Fort Lauderdale. "Secondary-tier cities" are still great choices for events, as they're usually well-connected and have all the hotel chains you'd find in larger tourist cities, but at a reduced cost.



BUFFETS, NOT BANQUETS

HCP meal caps are non-negotiable for anyone planning a healthcare event. As plated meal costs become prohibitively expensive for many organizations, a buffet is usually the most economical option. If you're opting for a more creative venue, you may be able to tie your buffet into the theme of your location, helping you maximize the impact without splashing out on a fancy plated meal.



CHOOSE A MOBILE APP

78% of companies that use a mobile event app say it contributes to a positive event ROI³.

For large, in-person healthcare and pharmaceutical events, such as expos, conferences, or seminars, an event app can significantly improve the experience for attendees. You can provide venue maps, workshop sign-ups, notifications about schedule changes, exhibitor listings, surveys, and more, helping attendees make the most of the event, and giving organizers valuable data about attendee behavior and movement.

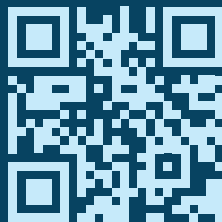
